## GENERAL INFORMATION

Willowood STICKER is an improved spreader-sticker-protectant for use with insecticides, fungicides, acaracides and pesticides, wettable spray powders and sun protectant sprays. It is a complex adjuvant designed to improve coverage, deposit and retention. Willowood STICKER improves the weatherability of spray deposits. It reduces losses due to light rain, dews and fog.

## DIRECTIONS FOR USE

This product may be used in dilute or concentrate sprays. Add Willowood STICKER to spray tank first.

PER 100 GALS. OR LESS OF SPRAY MIX PER ACRE

Acaracides and Fungicides .....	1/4 to 1 pint
Insecticides .....	1/4 to 2 pints
Wettable Spray Powders .....	1/4 to 1 1/2 pints
Sun Protectants .....	2 pints

Lower rates should be used in high volume dilute sprays.
