## Section 4. First aid measures

### Description of necessary first aid measures

## Section 5. Fire-fighting measures

### Extinguishing media

**Specific hazards arising from the chemical** : In a fire or if heated, a pressure increase will occur and the container may burst. ## Section 7. Handling and storage

### Precautions for safe handling



